Document A: Webpage - How Foreign Assistance and Irish Aid work (<https://www.concern.net/>)

What is Foreign Assistance?

In Ireland, our foreign assistance comes mainly from Irish Aid and the national overseas development programme. This organisation is funded by the Irish taxpayer. The term “foreign assistance” refers to anything that one country gives for the benefit of another country. Usually, this means higher-income countries provide development assistance to lower- and middle-income countries. This assistance includes money but can also be donations of goods or services, such as:

- Food aid and distribution
- Education
- Water, sanitation, and hygiene
- Infrastructure assistance
- Agriculture training
- Climate resilience support
- Peace-building activities
- Health care



The goal with all of these forms of international aid is to support a functioning global society. Irish Aid also responds to humanitarian crises, with the Rapid Response Corps working alongside United Nations organisations and Concern Worldwide.

How much does Ireland spend on foreign assistance?

Last year, the government spent over €867.5 million; this represents just over 0.3% of the GNP, meaning that €0.31 out of every €100 goes towards foreign assistance. In October of 2021, the government announced a €140 million increase in overseas development assistance for next year, bringing the total budget to over €1 billion for the first time. (Adapted)

DEFINITION OF HUMANITARIAN AID: Humanitarian aid is assistance that’s used to relieve suffering during emergency situations. This is different from development aid, which is assistance that goes to addressing ongoing issues that contribute to human suffering, (CONCERN adapted).

Document B: Behaviour & Attitudes: Public Engagement Study, February 2020, prepared for Dóchas by Ian Mc Shane, (Adapted).

dóchas is the association of Irish Non-Governmental Development Organisations. The purpose of Dóchas is to increase Ireland’s contribution to world development. They do this by being an independent representative voice of Ireland’s Development sector, in order to influence public debate and decision-making in Ireland and the European Union.


A need had been identified for statistically valid and reliable research amongst a nationally representative sample of the general public covering a broad range of topics related to understanding the general public’s experiences of, and attitudes towards, key areas of the Dóchas mission and to understand attitudinal and behaviour change in light of recent contemporary social change movements.

- In order to meet this need, Behaviour & Attitudes were commissioned to conduct a nationally representative online survey amongst adults aged 18+ in the Republic of Ireland with follow-on qualitative research to find out the current beliefs and motivations of the Irish public.




