





The Society of St Vincent de Paul (SVP) is the largest voluntary charitable organisation in Ireland. Our focus is on a practical approach to dealing with poverty, easing its effects on individuals and families by working mainly in person-to-person contact.

In addition to providing direct assistance to those in need, caring for the homeless, providing social housing, operating holiday homes and other social support activities, the Society promotes community self-sufficiency, helping people to help themselves.

The Society respects the dignity of those who contact us, offering help and advice when sought while assisting them towards long-term self-sufficiency in a relationship of friendship, trust and confidentiality.

What is the real-life experience of living in poverty?

- I'm worried the car might break down or the children will become ill. I'm praying the fridge won't break. I don't have enough money to plan for these uncertainties. What will I do? I don't like borrowing.
- I do as much planning and budgeting as I can. I'm happy if the rent, ESB and food bills are paid. I wish I could plan for months ahead...but it's difficult to plan when you're unsure about the basics.
- I can't get control, we can't make plans, it's like being in a deep hole, no matter what we do we can't get out of it. We climb up and fall back in.
- The children look for money for school trips. We often have to say no to even five euro, we just don't have it, even though we budget carefully. We have to say, "Sorry we can't"...they are very good kids and we hate that they feel different.
- I find life very hard, not being able to pay all my bills and always putting some on the long finger. The stress makes me sick. I'm always worrying knowing that my kids have to go without.

Document B: *Cost of Living Crisis Impact on Children, 2023. Executive Summary, Barnardos.*

In Barnardos, our core purpose is helping the most vulnerable children in society achieve their full potential regardless of their family circumstances, their gender, race or disability - *Because Childhood Lasts a Lifetime.*

Barnardos is concerned that cost of living increases are pushing more children in Ireland into poverty and negatively affecting their health, wellbeing and development. We have produced a report highlighting the growing impact that cost of living increases are having on children across the country. It sets out findings of a nationally representative survey of parents (315) conducted by Amárach Research. It also includes the voices of 30 parents currently supported through Barnardos services who took part in 1 to 1 interviews, both carried out in April 2023.

Over the past 6 months, have you and your child/children had to go without or cut down on any of the following due to cost of living increases?	April 2023	April 2022

The survey also found that almost three-quarters of parents (73%) stated that the increase in the cost of living has negatively affected their children over the past six months, with almost two in ten (17%) saying it has significantly affected them.

As the cost of living crisis continues there is a risk that more and more children will be pushed into deprivation and spend longer and longer without enough food, heat and electricity. It is vital that the Irish Government introduces immediate and long-term targeted policies, to ensure that all children, at a minimum, live in homes that have sufficient food and can provide regular meals, live in properly heated accommodation and don't go without electricity.


